Chickasaw Hall of Fame 2025 Nomination Form

Eligibility requirements:

The Chickasaw Nation accepts nominations of both living and deceased individuals who meet the eligibility requirements to be considered for induction into the Chickasaw Hall of Fame.

To be eligible to receive this high honor, nominees must have distinguished themselves in their business, profession, vocation or cultural craft (activity) thereby bringing honor to the Chickasaw people, and/or having made outstanding contributions to the Chickasaw Nation or society in general. An inductee must be a citizen of the Chickasaw Nation at the time of nomination. Nominees are not required to live in Oklahoma.

All living individuals selected for induction into the Chickasaw Hall of Fame must commit to being present for the induction ceremony and those who nominate citizens for the posthumous induction must attend, or the nominee may not be inducted that year. Current Chickasaw Nation elected officials and employees are ineligible for induction into the Chickasaw Hall of Fame.

Deadline for 2025 nominations:

Nominations must be received by Friday, November 1, 2024 for consideration for the 2025 induction ceremony.
